

Collection and Recycling Arrangements in the UK

Under the UK Waste Electrical and Electronic Equipment (WEEE) Regulations, for old equipment that you have bought before August 2005 which is being replaced on a one-for-one, like-for-like basis by the purchase of new Brainlab equipment, Brainlab is required to provide arrangements for the collection, treatment, recycling and recovery of the old equipment. The old equipment that your new purchase from Brainlab replaces is referred to as Historic WEEE.

Under the UK WEEE Regulations, Brainlab is also required to provide arrangements for the collection, treatment, recycling and recovery of any new electrical and electronic equipment that you buy from Brainlab after August 2005, when that new equipment eventually becomes waste. This is referred to as New WEEE.

Brainlab products are very competitively priced. Any new increase in operating costs for manufacturers such as Brainlab is normally reflected in a price increase in the product. However, instead of increasing the prices of our products, Brainlab has decided to pass these new environmental costs directly back to our customers as and when they occur. We believe in being transparent with you on any new environmental costs that our products need to address.

Our approach to these environmental costs is:

- Brainlab pays for the costs of data management and reporting to the Environment Agency to demonstrate compliance with all administrative requirements of the WEEE Regulations.
- you pay for transportation of your WEEE to Brainlab's appointed recycler in the UK.
- you pay for the costs of treatment, recycling and recovery of the WEEE to meet the targets set by the WEEE Regulations.

Brainlab has established a recycling contract with the European Advanced Recycling Network (EARN). As a business service to customers, Brainlab will in the first instance cover the costs of treatment, recycling and recovery of the equipment on arrival at the EARN recycling facility in the UK. These costs will then be charged back to you by Brainlab. All New WEEE that arises from the purchase of Brainlab products is classed as non-hazardous waste and does not contain Persistent Organic Pollutants (POPs) to class it as hazardous WEEE. As the waste holder, it is your responsibility to confirm that the waste Brainlab equipment has not become hazardous during the product use. For example, if the equipment has become contaminated during use, please follow the recommended decontamination procedure.

It is your responsibility to arrange and pay for costs of collection and transportation to the recycler. In order to meet UK Duty of Care Regulations for waste disposal, you should use one of the following carriers (which hold a valid Waste Carriers license):

To comply with the UK Duty of Care Regulations the transport of your waste to the recycler must be accompanied by suitable documentation. You must also keep a signed copy of this documentation for two years.

In order to meet this requirement and to enable EARN to identify Brainlab equipment upon arrival at the recycler's address, please use the Recycling Label for UK Customers. Complete the label with your company details and attach it to a suitable box for transport to EARN.

Under Section 27 of the WEEE Regulations, information on the quantities and categories of Brainlab electrical and electronic equipment put on the market, reused, recycled and recovered within the UK must be reported by the end of each compliance period. EARN will prepare the recycling data report for Brainlab. Information in the EARN recycling data report will be provided by Brainlab when it becomes available.



Waste Electrical and Electronic Equipment for Recycling from Brainlab Customers

Under the UK WEEE Regulations, when customers buy new electrical and electronic equipment from Brainlab they are entitled to send waste electrical and electronic equipment for recycling on a one-for-one, like-for-like basis. Customers are also entitled to send the new Brainlab equipment for recycling when it ultimately becomes waste. Brainlab has established a recycling contract with the European Advanced Recycling Network (EARN). Please complete this label and attach it to a suitable box or other container for transport to the EARN recycler.
